Project Summaries and Points of Contact

Voter Registration Systems:

Awards that have been committed include the following:

• A contract to the Office of the Ohio Secretary of State totaling \$223,300, through which Ohio Secretary Jennifer Brunner, Kentucky Secretary of State Trey Grayson and Indiana Secretary of State Todd Rokita will partner with the United States Postal Service (USPS) to test the efficacy of including voter registration forms in the change of address packets that are sent to movers who file change of address requests with the USPS in three postal markets. The three postal regions represent 61 counties impacted by this project.

- A subgrant to the Office of Minnesota Secretary of State Mark Ritchie totaling \$67,900 in the form of a planning grant to prepare computer programming and work with the Hubert H. Humphrey Institute on Public Policy at the University of Minnesota to design evaluation standards for an ambitious new program to automatically update voters' addresses as they move. (This funding is contingent on the approval of the Minnesota Commissioner of Finance.)

- A contract to the Overseas Vote Foundation (OVF) totaling \$100,000 to automate the complex process facing military and civilian overseas voters attempting to register to vote and request absentee ballots through a user-friendly, accessible online system, available at <u>www.overseasvotefoundation.org</u>. In addition to direct access through OVF's Web site, the web applications have been adopted by the Secretaries of State in Alabama, Minnesota and Ohio.

- A subgrant to Massachusetts Institute of Technology (MIT) totaling \$124,000, where Professors Stephen Ansolabehere from MIT and Alan Gerber from Yale University will conduct a pilot study to audit voter registration lists and gauge the feasibility of various methods designed to evaluate the accuracy of baseline lists, develop methods for improving list quality and determine the feasibility of performing a nationwide assessment of voter registration systems. The pilot will be conducted based on the registration records from four jurisdictions: Los Angeles County, CA; Maricopa County, AZ; New Haven, CT and Miami-Dade County, FL.

Vote Centers

Awards that have been committed include the following:

• A contract to Ball State University totaling \$202,600, to assess the use of voter centers in two Indiana counties, Wayne and Tippecanoe. The assessment will examine the impact on voter turnout, cost, efficiency on Election Day and public opinion. The project has the support of local election officials and Indiana Secretary of State Todd Rokita and is expected to inform a decision in 2009 about whether or not to allow other counties to adopt vote centers.

The assessment will examine the impact on voter turnout through exit polls, post-election surveys and statistical analysis and has the support of a leading election official in Colorado that designed the first vote centers along with election officials in Fort Bend and Lubbock.

Audits of Elections

Awards that have been committed include the following:

• A contract to the Maryland State Board of Elections totaling \$77,900 to research and develop a comprehensive post-election audit based on professional auditing principles, detailed statistical analysis, and election administration expertise provided by Prince George's, Charles, and Caroline counties. The post-election audit to be developed will be a practical and usable audit process that will demonstrate to candidates and the public that the election was conducted accurately, that voting equipment counted votes properly and that only qualified voters cast ballots in the election. The audit will also help election officials identify where improvements need to be made.

The project is working closely with Chris Thomas, Michigan's State Election Director, and local election officials and has built in multiple focus groups with election officials to complement their strong academic and analytical abilities.

Online Training for Poll workers

Awards that have been committed include the following:

• A contract to the New Hampshire Attorney General's Office totaling \$189,500, through which state officials in the Offices of the Attorney General and Secretary of State and academics will pilot an online education system to train poll workers and also educate citizens on their rights and responsibilities as voters. Using three independent rigorous evaluation methodologies, the University of New Hampshire will provide empirically-based data on the relative effectiveness of interactive online training.

Election Performance Assessment

Awards that have been committed include the following:

• A contract to Reed College totaling \$137,000, through which an academic team will design and test an enhanced residual vote measure. At this juncture, the residual vote rate is one of the few tools that provide an accepted means for comparing state election performance. Through this project, the team will design and test more sophisticated and detailed measures that take into account the technology and mode of balloting, in collaboration with election officials in Florida and North Carolina.
